

Instructions for Obtaining MTNF Chadwick/Sutton Bluff Off Highway Vehicle Areas Annual or Daily Permits

OHV Registration Forms

The MTNF OHV Permit Registration form is to be filled out and signed for each individual OHV that is going to be ridden on the trails at either Chadwick or Sutton Bluff or both. **Please keep in mind that UTVs are not allowed on the Chadwick trails. UTVs under 50” may be ridden on Sutton Bluff trails. By signing this registration slip you are certifying that the OHV you are registering fits the definition of the selected category.** The Forest Service or a designated vendor will fill out the Permit Number, Date Issued and Time Issued portions of this form.

Once you have obtained and filled out the OHV Registration Form there are several options that can be used to purchase your OHV permits. **Please note that both the daily and the annual permits are valid for use at both the Sutton Bluff and Chadwick OHV trails.** You can purchase these permits from the Forest at three different office locations; however, if you have questions concerning a particular trail we recommend that you contact the district office that oversees that area. The Salem Ranger District is responsible for Sutton Bluff Motorcycle and ATV Trails and campground. The Ava/Cassville/Willow Springs Ranger District is responsible for the Chadwick Motorcycle and ATV Trails and Cobb Ridge campground. There are several vendors in the Chadwick area (in Chadwick, and Sparta) that sell the MTNF Chadwick/Sutton Bluff OHV permits and one vendor in Centerville, MO that sells permits to customers in the Sutton Bluff area. You may also purchase permits through the mail or over the phone.

If you wish to purchase an ATV permit over the phone by credit card, you will need to print or obtain a paper copy of the registration form, fill it out completely, sign it, and then fax the signed form to the Salem or Ava district office or to the Forest Supervisor's office (We can not accept the form without a signature). Contact the office that you are faxing the registration form to and be prepared to give them your credit card information (Visa and MasterCard are the only cards accepted). The Forest will not mail permits out to customers until payment and a signed copy of the registration slip is received. Keep in mind that these permits are valid only for the trails and do not permit you to ride Forest Service or County Roads. It is recommended persons intending to ride an ATV at Sutton Bluff also purchase a Reynolds County ATV permit, and persons intending to ride an ATV at Chadwick also purchase a Christian County ATV permit. Trails at Sutton Bluff and some trails at Chadwick are connected by Forest Service and County Roads. Non-street legal dirt bikes may not be ridden on any roads. See the list below for possible locations to obtain a MTNF Chadwick/Sutton Bluff Off Highway Vehicle Areas Annual or Daily Permit and contact information to obtain the Reynolds County and Christian County ATV permits.

If you wish to purchase permits through the mail, you will need to print or obtain a paper copy of the registration form, fill it out completely, sign it, and then mail the signed form to the Salem or Ava district office or to the Forest Supervisor's office. If you will be purchasing a daily permit please enclose a note or somewhere on the registration form indicate the exact day or days that you will be riding the trails. Keep in mind that it may take up to ten days from the date of receipt of your request for your permit to reach you. If you wish to have the ATV permit mailed somewhere other than the address that is given on the form, make note of that as well. Make checks and money orders payable to the USDA Forest Service. Payment must accompany registration slips sent in the mail before ATV permits will be distributed. If you have any questions contact the district office that oversees the trail you are purchasing the permit for or the Forest Supervisor's office.
