



Reds Meadow/ Devils Postpile National Monument Shuttle Fee - Fall 2010 Effective 9/9/2010

All visitors utilizing the facilities and services in the Reds Meadow Valley pay a shuttle fee or a standard amenity fee. Fees are collected during the entire season. Shuttle Passes are available for purchase at the Mammoth Mountain Adventure Center and standard amenity fees are paid at Minaret Fee Station.

Shuttle Bus: The mandatory shuttle bus runs 7:00 a.m. to 7:00 p.m. daily from approximately mid-June through mid-September. The shuttle leaves the Adventure Center at Mammoth Mountain Main Lodge. Please plan your trip to coincide with the shuttle bus schedule.

Vehicle Use and Exceptions: Excessive vehicle use and resource protection are the primary reasons for a mandatory shuttle bus. When the shuttle is in operation, exception vehicles must pay the standard amenity fee. When the shuttle bus is not in operation, all vehicles are required to pay the standard amenity fee. Exceptions to the mandatory shuttle bus have been recognized during the last twenty years of operation. Following is a list of vehicle exceptions:

- People with a disability placard
- Horse trailers or other livestock
- Campers staying in developed valley campgrounds
- Overnight resort guests
- Hunters transporting weapons and large game
- Vehicles entering the valley before 7:00 a.m. or after 7:00 p.m.
- Vehicles carrying inflated float tubes or car top boats
- Administrative vehicles: deliveries, contractors, permittees, concessionaires, Forest Service and National Park Service employees.

Please Note: Vehicles in the valley are sometimes damaged by bears. It is advisable to leave private vehicles in the Mammoth Mountain Main Lodge parking lot whenever possible. Large food storage lockers are available at campgrounds and trailheads in the valley, and additional portable food storage containers are available for rent at Mammoth Lakes Welcome Center for \$1 per day with a \$5 minimum. (1st come, 1st served – not reserveable) Hike Safely!

2010 Fall Fee Schedule

MANDATORY SHUTTLE PASSES	COST (Prices are subject to change 2011) Last Day of Shuttle for 2010 – 9/8/2010 Mandatory Shuttle 7:00 a.m. to 7:00 p.m.
Day pass	\$7.00 per person, children 3 to 15 - \$4.00, 2 and under - free
Wilderness Hikers	\$7.00 per person. This one time fee is good for the duration of stay in the valley - based on wilderness permit
Three day pass	\$14.00 per person, children 3 to 15 - \$8.00, 2 and under - free
Season pass	\$35.00 per person, children 3 to 15 - \$20.00, 2 and under - free

STANDARD AMENITY FEE <i>for exception vehicles and when shuttle is not running</i>	COST (Prices are subject to change) Effective Date – 9/9/2010
Day pass	\$10 per vehicle/day. Also accepted at Mono Lake South Tufa and Schulman Grove Day Use Areas.
Three day pass	\$20 per vehicle. Good for any 3 of 5 consecutive days. Also accepted at Mono Lake South Tufa and Schulman Grove Day Use Areas.
Season pass	\$35.00 per person. Good for per vehicle entrance for purchaser and all passengers. Also accepted at Mono Lake South Tufa and Schulman Grove Day Use Areas.
Interagency Passes	Annual Pass: \$80 Senior Pass: \$10 (62 and older) Access Pass: Free (with proof of permanent disability) Note: These passes are good at most National Parks, National Monuments, US Forest Service, Fish & Wildlife Service, Bureau of Land Management, and Bureau of Reclamation fee areas for entrance fees or standard amenity fees. Not good for expanded amenity fees.
Tour Bus	\$70 per 20- passenger sized bus \$140 per 20+ passenger sized bus Note: Fee determined by bus size and not number of passengers. Also accepted at Mono Lake South Tufa and Schulman Grove Day Use Areas.

***Shuttle Bus Passes and Exception Passes are NOT interchangeable!** Shuttle passes are sold at the Adventure Center by Mammoth Mountain employees, and shuttles are operated by the Eastern Sierra Transit Authority (ESTA). Vehicle passes are sold by the US Forest Service and National Park Service employees at Minaret Vista and are not valid for shuttle use into or out of the Valley.
