

# ORDER 12-182

## SPECIAL RESTRICTION

### CAMP CREEK, ST. CLAIR, BARTLETT, AND VERDE RIVER AREAS

### TONTO NATIONAL FOREST

**Pursuant to 36 CFR §261.50(a)**, the following is **prohibited year-long** within the specified National Forest System lands under the primary jurisdiction of the Forest Service located within all or part of

Sections 23, 26, 27, 33, 34, & 35, T. 7 N., R. 5 E.,

Sections 2, 3, 10, 11, 12, 13, 14, 23, 24, 25, 26, 27, 33, 34, 35, & 36,  
T. 7 N., R. 6 E.;

Sections 19, 29, 30, 31, & 32, T. 7 N., R. 7 E.;

Sections 1, 2, 3, 10, 11, 12, 13, 14, 15, 22, 23, 24, 25, 26, 27, 34, 35, & 36,  
T. 6 N., R. 5 E.,

Sections 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 27,  
28, 29, 30, 31, 32, 33, & 34, T. 6 N., R. 6 E.,

such areas (as shown on the attached map) being located within the Cave Creek  
Ranger District of the Tonto National Forest:

#### **Discharging a firearm or gas gun. 36 CFR §261.58(m)**

**Pursuant to 36 CFR §261.50(e)**, the following persons are exempt from this  
Order:

1. Any person with authorization in writing from a Forest Officer, which specifically authorizes the otherwise prohibited act.

2. Any Federal, State, or local officer in the performance of an official duty.
3. Any person taking game in accordance with Arizona hunting laws (ARS Title 17) and Arizona Game & Fish Commission Orders.

NOTE: This prohibition is in addition to those prohibitions enumerated in Subpart A of 36 CFR §261 and any other special restrictions pertaining to the described areas. Specifically note that **Order 12-137** (as revised) prohibits discharging a firearm, air rifle, or gas gun within the Needle Rock Recreation Area, which borders the above described areas along their southeastern border. Also note that **Order 12-4** (as revised) prohibits possessing or using a motor vehicle off any National Forest System Road, which applies to all of the above described areas.

**VIOLATION OF THESE PROHIBITIONS IS PUNISHABLE BY A FINE OF NOT MORE THAN \$5,000 FOR AN INDIVIDUAL OR \$10,000 FOR A LEGAL ENTITY OTHER THAN AN INDIVIDUAL OR IMPRISONMENT FOR NOT MORE THAN SIX (6) MONTHS, OR BOTH. 16 USC, §551, 18 USC §3559 and §3571.**
