Four year-round rifle ranges are located on the Enoree Ranger District: Fairforest, Indian Creek, Leeds and Philson Crossroads. All four ranges have been designed with the firearm enthusiast in mind. All rifle ranges have six shooting tables under a shelter, are open year-round for day use, and do not have fees.

Leeds is ADA accessible and accommodates targets at 25 and 100-yard intervals.

Fairforest is ADA accessible, with paved paths to targets and accommodates targets at 25 and 100-yard intervals.

Indian Creek is ADA accessible, with paved paths to targets and accommodates targets at 25 and 100-yard intervals.

Philson Crossroads is ADA accessible, with paved paths to targets and accommodates targets at 25 and 100-yard intervals.

## Directions

**From Hwy. 72 and Leeds Rd.**, County 12-25, drive north 1.8 miles. Turn left at Leeds Rd., County 12-25, and County Rd. 49 and drive 0.10 miles. Cross over railroad tracks and drive 3.4 miles north to Park Rd., County 12-574. Turn left onto Park Rd., County 12-574 and drive 0.05 miles. Turn left onto FS Rd. 307 and drive 0.5 miles to rifle range on right side.

**From Hwy. 9 and County 49**, drive south 5.6 miles. Turn right at Park Rd., County 12-574, and drive 0.05 miles. Turn left onto FS Rd. 307 and drive 0.5 miles to rifle range on right side.

## Regulations

- All weapons must meet South Carolina firearm safety standards. See <http://www.dnr.sc.gov> for more details.
- No alcoholic beverages
- No tracer or incendiary ammunition
- Skeet and trap shooting is not permitted
- Shoot only at proper targets mounted on a self-provided target stand or holder.
- Shoot only from the firing line, downrange and into the backstop
- Shooters under the age of 16 must be accompanied by adult
- Properly dispose of litter, including targets.
