On 04/12/2011, at 10:00 AM, sealed bids will be opened in the Yreka, California for the Board Roadside Hazard Tree Removal sale. This sale is located in T41S, R1W, Sections 15, 16, and 17; W. M.; T46N, R9W, Sections 2, 3, 4, and 10; T47N, R8W, Section 31; T47N, R9W, Sections 4, 6, 8, 10, 12, 14, 22, and 26; T47N, R10W, Sections 1, 9, and 12; T48N, R8W, Sections 18, 20, 21, 28, 29, and 30; T48N, R9W, Sections 13, 22, 23, 26, 28, and 36; T48N, R10W, Sections 31 and 32, M.D.M.. Timber sale Contract 2400-6 will be used. The termination date for this sale is 03/31/2013. This is a small business set-aside sale.

This sale will be preferentially awarded to a qualified small business concern. In the absence of any bids from a self-certifying qualified small business concern, the sale will be readvertised without restriction on the size of bidders.
