On 01/06/2011, at 10:00 AM, sealed bids will be opened in the Enoree Ranger District Office, 20 Work Center Rd, Whitmire, SC 29178 for the EN 135, 136 sale. This sale is located in northern Newberry Co. near the community of Renno. Access to the Sale Area is via State Road 26 (Renno Rd), County Rd C30136, FS road E136-1A, FS 427 (Gladys Rd), and E135-1. The primary product in this sale is southern yellow pine sawtimber and a smaller component of pine pulpwood, hardwood sawtimber and pulp. Timber sale Contract 2400-6T will be used. The termination date for this sale is 08/15/2012.

There are 2.64 miles (4.25 kilometers) of specified road reconstruction. A specified road construction cost of \$45,972.00 has been allowed in the appraisal for this work.
