

ORDER  
FOREST DEVELOPMENT ROADS  
UMATILLA NATIONAL FOREST

Pursuant to 36 CFR Sec. 261.50(b), the following act is prohibited on the roads described in this order, all within the Umatilla National Forest, until further notice:

- (1) Using any vehicle with wheels or tracks equipped with metal lugs.  
36 CFR 261.54(a).

Pursuant to 36 CFR Sec. 261.50(e), the following persons are exempt from this order:

- (1) Persons with a permit.
- (2) Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.

ROAD DESCRIPTION

Road #53 (Western Route) from its junction with U.S. Highway #395 to its junction with Willow Creek County Road in Section 21, T.4S., R.28E., Willamette Meridian, in the State of Oregon.

Road #52 (Ukiah Granite) from the end of county road in Section 1, T.6S., R.35E., Willamette Meridian, to the junction with Forest Service Road #51.

Road #63 (Lookingglass) from end of county road in Section 24, T.3N., R.39E., to junction with Forest Service Road #64.

Road #64 (Jubilee) from its junction with State Highway #204 to its junction with Forest Service Road #6400250 (Jubilee Campground).

Road #62 (Troy-Lookingglass) from its junction with Forest Service Road #63 (Lookingglass) to section line between Sections 2 and 3, T.5N., R.41E.

Road #65 (Touchet) from end of county road southerly to its junction with Forest Service Road #46.

Road #10 (Olive Lake Drive) from its junction with Forest Service Road #55 (Texas Bar) to its junction with Forest Service Road #73 (at Granite).

Road #55 (North Fork John Day) from its junction with U.S. Highway #395 to its junction with Forest Service Road #5505 (Turner Basin).

Road #2039 (Bull Prairie) from its junction with State Highway #207 to Bull Prairie Lake.

Road #31 (Summit Road) from its junction with State Highway #204 to its junction with State Highway I-84.

Road #54 (Pearson Creek) from the East Birch Creek County Road to the junction with State Highway #244.

Road #47 (Tucannon) from end of county road in Section 21, T.10N., R.41E., to junction of Road #4712 and #4713.

Road #40 (Pomeroy Troy) from end of county road in Section 4, T.9N., R.42E. to junction of Road #42.

Road #31 (Summit Road) from its junction with Interstate Highway I-84 to its junction with State Highway #244.
