



NOTE: Management Areas 4.21, 4.3, 5.11, 5.13, 5.21 and 5.41 contain lands suitable for timber harvest. However, not all acres within these management areas are necessarily suitable for harvest.

NOTE: The management area boundaries on this map were computer generated. These lines and their locations are only approximate at this scale. Since the base map was not computer generated, there may be some distortion between the base map and the computer generated management area boundaries.

NOTE: The management areas on this map are further explained in Chapter 4 of the Land and Resource Management Plan. The differences between alternatives may be better understood if the reader compares alternative maps as the accompanying Environmental Impact Statement is being reviewed.
