APPENDIX D: FOREST PROJECTIONS IN ROADLESS AREAS

INTRODUCTION

To analyze the potential consequences of the alternatives, the amount of potential tree-cutting, sale or removal activities and road construction/reconstruction under each alternative was projected for the next 15-years. These projections were gathered from personnel on each national forest in Colorado, for each alternative and their roadless areas as well as the acres removed from roadless by the particular alternative. For each roadless area and the acres removed, the forest staff considered factors such as: what was prohibited or limited under each alternative; any additional restrictions in their forest plan; the need for specific land uses or management actions that would require tree-cutting, sale or removal or road construction/reconstruction; topographic and budgetary constraints; and other factors. These projections help define the analysis framework from which to compare the potential effects of the alternatives. No tree-cutting, sale or removal or road construction/reconstruction activities are actually proposed as part of this analysis; thus these projections are speculative. The assumptions underlying these projections are described in detail in chapter 3-Analysis Framework.

EXPLANATION OF TABLE D-1

Table D-1 displays those specific roadless areas where tree-cutting, sale or removal or road construction or reconstruction activities are projected by alternatives and are: high (plans are underway or there is a clear need for the activity but no proposals at this time); low (limited needs, perhaps to meet a forest plan desired conditions, but uncertain as to whether a project would be proposed); or not capable or physically not possible to construct a road or cut trees, very expensive, low interest or need (codes H, L, or 0, respectively). Because these are only general projections and do not identify site specific projects, any level of activity within the identified roadless area could be described by the L or H. There is no differentiation between what might be a large project in a small roadless area or a small project in a large roadless area.

For many of the roadless areas there are several rows. The primary names listed are the CRA names, which in some cases differ from IRA names (refer to the crosswalk between IRA and CRA names in appendix A). Information listed in those rows is for those acres that are common between the CRAs and IRAs. The information in the rows with “acres added” (referred to generally as “new roadless acres”) are those acres only within the CRAs. The information in the rows with “acres removed” (referred to generally as “substantially altered” areas) are those acres only within the IRAs and the name listed is the IRA name.

The column ‘MGT CAT’ refers to how those acres are currently assigned to be managed by the respective forest plan. These categories are further described in appendix B. The column ‘MAP LABEL’ refers to the Forest Alternative maps that are available on the website

(<https://www.roadless.fs.fed.us>) and identifies individual areas that have been removed from or added to existing roadless areas. The 'Optional Comments' column includes any specific information that the forest may have concerning the possible projected project. Not all rows with projections have a comment, but comments are included to give a general indication of the types of projection that may occur in the future within the roadless areas. Only those parts of roadless areas that are greater than 50 acres were considered for this analysis.
