The Station Fire Recovery Area begins at the intersection of Big Tujunga Canyon Road and the Angeles National Forest boundary, Township 2 N, Range 14 W, Section 1, San Bernardino Base and Meridian; then continues west along the Angeles National Forest boundary to the western boundary of the private inholding at Forest Service Road No. 3N43, Township 2 N, Range 14 W, Section 2; then continues north and east along the private inholding boundary to its intersection with the East Fork of Akens Canyon, Township 2 N, Range 14 W, Sections 1 and 2; then continues north along the East Fork of Akens Canyon to its intersection with Forest Service Road No. 3N30.1, Township 3 N, Range 14 W, Section 36; then continues north along the eastern edge of Forest Service Road No. 3N30.1 to its intersection with Forest Service Road No. 3N29.1 (Gold Creek Road), Township 3 N, Range 14 W, Section 25; then continues north along the eastern edge of Forest Service Road No. 3N29.1 to Gold Creek Saddle and its intersection with Forest Service 3N60, Township 3 N, Range 13 W, Section 19; then continues north along the eastern edge of Forest Service 3N60 to its intersection with Forest Service Road No. 3N32 (Mendenhall Ridge Road), Township 3 N, Range 13 W, Section 17; then continues west along the southern edge of Forest Service Road No. 3N32 to its intersection with Forest Service Trail 13W02 (Yerba Buena Trail), Township 3 N, Range 13 W, Section 18; then continues north along the eastern edge of Forest Service Trail 13W02 to its intersection with Forest Service Road 4N35, Township 3 N, Range 13 W, Section 7; then continues northeast along the southeastern edge of Forest Service Road 4N35 to its intersection with Forest Service Road 3N17 (the Santa Clara Divide Road), Township 4N, Range 14 W, Section 33; then continues west along the northern edge of Forest Service Road 3N17 to its intersection with Forest Service Road 4N37, Township 4 N, Range 13 W, Section 30; then continues north along the eastern edge of Forest Service Road 4N37 to its intersection with the Angeles National Forest northern boundary, Township 4 N, Range 13 W, Section 18; then continues east along the Angeles National Forest boundary to its intersection with Forest Service Road 4N33 (Moody 4WD Truck Road), Township 4 N, Range 13 W, Section 24; then continues south along the eastern edge of Forest Service Road 4N33 to its intersection with Forest Service Road 4N32, Township 4 N, Range 13 W, Section 24; then continues southwest

along the southeastern edge of Forest Service Road 4N32 to its intersection with Forest Service Road 3N17 (the Santa Clara Divide Road), Township 4 N, Range 13 W, Section 33; then continues east along the southern edge of Forest Service Road 3N17 to its intersection with Forest Service Road 3N17.2, Township 3 N, Range 11 W, Section 10; then continue south along the western edge of Forest Service Road 3N17.2 to its intersection with Forest Service Road No. 3N14, Township 3 N, Range 11 W, Section 10; then continues south along the western edge of Forest Road No. 3N14 to its intersection with the Charlton-Chilao Developed Recreation Area boundary, Township 3 N, Range 11 W, Sections 21 and 22; then continues south along the Charlton-Chilao Developed Recreation Area boundary to its intersection with Forest service Road 3N16.2, Township 3 N, Range 11 W, Sections 33 and 34; then continues east along the southern edge of Forest Service Road 3N16.2 to its intersection with Forest Service Road 3N16.1, Township 2 N, Range 11 W, Section 3; then continues east along the southern edge of Forest Service Road 3N16.1 to its intersection with Forest Service Trail 11W06 (Silver Moccasin Trail), Township 2 N, Range 11 W, Section 3; then continues south along the western edge of Forest Service Trail 11W06 to its intersection with State Highway 2 (Angeles Crest Highway), Township 2 N, Range 11 W, Section 9; then continues west along the northern edge of State Highway 2 to its intersection with Angeles Forest Highway and Forest Service Trail 12W03A (Nature's Canteen Trail), Township 2 N, Range 12 W, Section 8; then continues east along the southern edge of Forest Service Trail 12W03A to its intersection with Forest Service Road 2N57, Township 2 N, Range 12 W, Section 9; then continues south along the western edge of Forest Service Road 2N57 to its intersection with National Recreation Trail 11W14 (Gabrieleno National Recreation Trail), Township 2 N, Range 12 W, Section 9; then continues south along the western edge of National Recreation Trail 11W14 to its intersection with Forest Service Trial 11W08 (Bear Canyon Trail), Township 2 N, Range 12 W, Section 17; then continues southeast along the southwestern edge of Forest Service Trail 11W08 to its intersection with Forest Service Road 2N50.1, Township 2 N, Range 12 W, Section 27; then continues south along the western edge of Forest Service Road 2N50.1 to the Mount Lowe Campground, Township 2 N, Range 12 W, Section 26; then continues east around the perimeter of the Mount Lowe Campground, Township 2 N, Range 12 W, Section 26; then continues west along the northern edge of Forest Service Road 2N25.1 to its intersection with Forest Service Trail 12W18 (Sunset Ridge Trail), Township 2 N, Range 12 W, Section 34; then continues west along the northern edge of Forest Service Trail 12W18 to its intersection with Forest Service Road 2N65.1, Township 2 N, Range 12 W, Section 33; then continues west along the northern edge of Forest Road No.

2N65.1 to its intersection with private inholding, Township 2 N, Range 12 W, Section 32; then continues west along the private inholding boundary to its intersection with National Recreation Trail 11W14 (Gabrieleno National Recreation Trail), Township 2 N, Range 12 W, Section 31; then continues north along the eastern edge of National Recreation Trail 11W14 to its intersection with the Falls Canyon tributary, Township 2 N, Range 12 W, Section 30; then continues west along the northern edge of the Falls Canyon tributary to its intersection with State Highway 2 (Angeles Crest Highway), Township 2 N, Range 12 W, Section 30; then continues north along the eastern boundary to its intersection with the private inholding, Township 2 N, Range 12 W, Section 19, and Township 2 N, Range 13 W, Section 24; then continues north and west on the private inholding boundary to its intersection with State Highway 2 (Angeles Crest Highway), Township 2 N, Range 13 W, Section 24; then continues north along the eastern edge of State Highway 2 to its intersection with the private boundary, Township 2 N, Range 13 W, Section 24; then continues west and north on the private inholding boundary to its intersection with State Highway 2 (Angeles Crest Highway), Township 2 N, Range 13 W, Section 13; then continues north along the eastern edge of State Highway 2 to its intersection with Forest Service Road 2N80, township 2 N, Range 13 W, Section 13; then continues west along the northern edge of Forest Service Road 2N80 to its intersection with the private inholding, Township 2 N, Range 13 W, Section 13; then continues south and west on the private inholding boundary to its intersection with Forest Service Road 2N80, Township 2 N, Range 13 W, Sections 13 and 14; then continues south along the western edge of Forest Service Road 2N80 to its intersection with Forest Service Road 2N76 (Mount Lukens Road), Township 2 N, Range 13 W, Sections 14 and 23; then continues west along the northern edge of Forest Service Road 2N76 to its intersection with the private inholding, Township 2 N, Range 13 W, Section 16; then continues west on the private inholding boundary to its intersection with Forest Service Road 2N76 (Mount Lukens Road), Township 2 N, Range 13 W, Sections 9 and 16; then continues west along the northern boundary of Forest Service Road 2N76 to its intersection with the private inholding, Township 2 N, Range 13 W, Section 16; then continues west on the private inholding boundary to its intersection with Forest Service Road 2N76, Township 2 N, Range 13 W, Sections 16 and 17; then continues west along the northern edge of Forest Service Road 2N76 (Mount Lukens Road) to its intersection with the private inholding, Township 2 N, Range 13 W, Section 17; then continues south on the private inholding boundary to the Angeles National Forest boundary, Township 2 N, Range 13 W, Section 17; then continues west along the Angeles National Forest boundary to the starting point.
