This project provides funding to the Heber/Kamas Ranger District through Title II of the Act for restoration, maintenance and stewardship projects on the U-W-C NF federal lands by P.L. 106-393. Title II funds will be used to employ a YCC Crew of five youth (between the ages of 14-18) and one supervisor that will work on projects to restore fish and wildlife habitat and provide maintenance of roads, trails, facilities and construction of fences to improve forest ecosystems in addition to the primary goal of getting youth involved in outdoor activities and gaining a better understanding of forest ecosystems.
