On 09/27/2011, at 11:00 AM, sealed bids will be opened in the Forest Supervisor's Office, Attn: Timber Mgmt., Room 238D, P.O. Box 1270, Hot Springs, AR 71902 for the Wile E.'s Revenge sale. This sale is located in T1N, R25W, Sections 30-32; T1S, R25W, Sections 5-8, 18 & 19; T1N, R26W, Sections 25,35 & 36; T1S, R26W, Sections 1, 2, 10-14 & 24; Montgomery County, Arkansas.. Timber sale Contract 2400-6T will be used. The termination date for this sale is 10/31/2017.

There are 2.17 miles (3.50 kilometers) of specified road reconstruction, 5.66 miles (9.10 kilometers) of specified road construction, and 1 specified road bridge. A specified road construction cost of \$740,676.00 has been allowed in the appraisal for this work.
