On 10/11/2011, at 01:00 PM, sealed bids will be opened in the Long Cane Ranger District Office, Edgefield, SC for the LC 284,285,286,288 sale. This sale is located in both Edgefield and McCormick Counties, off of Highway 283 near Turkey Creek. Timber sale Contract 2400-6T will be used. The termination date for this sale is 06/30/2013. This is a small business set-aside sale.

This sale will be preferentially awarded to a qualified small business concern. In the absence of any bids from a self-certifying qualified small business concern, the sale will be readvertised without restriction on the size of bidders.

There are 4.21 miles (6.77 kilometers) of specified road reconstruction. A specified road construction cost of \$127,328.75 has been allowed in the appraisal for this work.

The estimated quantities in this contract have been determined prior to felling. The total estimated quantity on this sale is 9,513 CCF. The Forest Service encourages potential bidders to make their own inspection and estimate prior to bid submission.
