SPECIAL FOREST PRODUCTS HARVEST REQUIREMENTS / RESTRICTIONS / INFORMATION

General

- ✓ Keep this map with you at all times while hunting, picking, loading, and transporting products. Open Harvest Areas are colored GREEN on the map. Areas are not physically marked, posted, or identified on the ground. It is your responsibility to ensure you are on the open National Forest Lands shown in GREEN.
- ✓ Be careful not to disturb surrounding vegetation and to replace any soil, duff, and/or litter after harvest if the ground is disturbed. Every reasonable attempt should be made to protect the forest ground and soil and surrounding vegetation.
- ✓ All refuse and garbage generated shall be removed and disposed of at an approved, legal disposal site.

No Harvest Areas

- ✓ HARVESTING is NOT PERMITTED within any area on this map that is not colored green, usually shown AS CLEAR, GRAY, or WHITE.
- ✓ Most of these areas are not physically marked, posted, or identified on the ground. Regardless, the permittee is responsible for knowing his / her location at all times and avoiding these areas.
- ✓ No harvest is permitted within current operating contract areas such as firewood permit sale areas, timber sales, precommercial thinning areas, etc.; within administrative sites; or within 200 feet of campgrounds, rivers, streams, and ponds.

Vehicle Use & Safety

- ✓ Check weather and road conditions before leaving home. Be prepared for unexpected changes! Some public roads are not maintained in the winter. Always let someone know where you plan to harvest and when you expect to return. Carry a saw, shovel, gloves, boots, flashlight, first aid kit, and additional water and food.
- ✓ Motorized vehicles are NOT PERMITTED on roads closed by gates, earthen barriers or signed as closed to such vehicles. Vehicle shall remain on established roads.
- ✓ Do Not block, restrict, or interfere with anyone's use of roads or trails.
- ✓ Drive cautiously and defensively.
- ✓ Be aware that others WILL BE using the same road (ie. other harvesters, recreationists, log trucks, etc.).
- ✓ To help reduce the risk of spreading noxious weeds, insects and diseases, ensure your vehicle is clean of mud and plant materials before heading out to the forest.

Fires

- ✓ Obey all fire restrictions.
- ✓ Never leave your campfire unattended; extinguish all campfires before leaving.


Sustainable Harvest
