


Woods Ferry Recreation Area

Directions:

From Hwy. 72 and Leeds Rd., County 12-25, drive north 1.8 miles. Turn left, at intersection of Leeds Rd., County 12-25, and County Rd. 49 and drive 0.1 miles. Cross over railroad tracks and drive 3.4 miles north to Park Rd., County 12-574. Turn left onto Park Rd., County 12-574, and drive 3.6 miles to the end of the paved road.

From Hwy. 9 and County 49, drive south 5.6 miles. Turn right at Park Rd., County 12-574, and drive 3.6 miles to the end of the paved road.

Camping Facilities (April 1-October 31)

- 28 family campsites with tables and grills, seven of which have horse stalls.
- Two group campsites (#10 and #30). Campsite 10 has three horse stalls.
- Hot showers
- Centrally-located water spigots
- Single-family sites limited to no more than 8 people and 2 vehicles. Group sites limited to no more than 14 people and 4 vehicles.

Campsites 1 – 30: \$7 per night for family site; \$14 per night for group sites (10 & 30); maximum 14-day limit.

Day-Use Facilities

(open year-round/no water available Nov 1-Mar 31)



- Picnic tables and grills
- Two group picnic shelters
- Boat launch
- No fee for picnic area or boat ramp. Please note: there is no day use parking for horse trailers.

Reservations not accepted. Campground has self-service pay station. Campers have 30 minutes to pay for site at information/fee station.
