



Recreation fees are an investment in outdoor recreation. Current and future generations will benefit as 95% of the funds are reinvested in the facilities and services that visitors enjoy, use and value.

Accomplishments Provided with Recreation Fees on the White Mountain National Forest:

- Ensured that a welcoming face was available to answer questions at Forest Service visitor information centers. A total of 150,000 visitors were served at four centers.
- Staffed Lower Falls Day Use site. This busy site receives over 15,000 visitors each summer.
- Purchased bear-proof food storage boxes to help reduce encounters between visitors and native black bears.
- Hosted and mentored a Student Conservation Association intern, who successfully managed 4th Iron and Sawyer Pond camping areas.
- Replaced the front porch and toilet building roof at Radkee Cabin.
- Replaced fencing along the Boulder Loop Trail.
- Scraped and repainted historic Russell Colbath House. This site was staffed five days a week with Forest Service employees, volunteers, and partner organization members.
- Purchased and installed water safety signs at numerous locations around the forest.
- Provided "Woods in Winter" environmental education programs to approximately 125 local school children.
- Installed new cedar shingles at Blue Brook Shelter.

White Mountain National Forest Additional Accomplishments

- Completed routine operation and maintenance activities at all 48 recreation fee area sites, including: completed facility and grounds inspections, removed hazard tree and cleared brush, purchased cleaning supplies and materials, maintained signs and information boards, tested drinking water, collected garbage, serviced toilets and septic systems, re-painted parking lot stripes, mowed campsites, repaired vandalized facilities, and provided law enforcement presence.
- Plowed snow at numerous trailheads to provide winter hiking, snowshoeing, mountaineering, and skiing access.
- Funded recreation technicians and information specialists who continue to provide wildlife interpretive and “hikeSafe” programs, as well as recreation information at numerous sites.


