## EMERGENCY PROHIBITIONS

### FOREST SUPERVISOR ORDER NO. 08-13-08-12-05 ROAD 920A CLOSURE

Pursuant to authorities found in 36 CFR 261.50(a) and (b), and 36 CFR 261.53(e), and due to severe erosion which has occurred that has compromised the road bed and jeopardizes public health and safety, I am closing the following area:

**AREA CLOSED:** Forest Service System Road 920A in Unit 71. (See the attached map for the location.)

**EFFECTIVE DATE OF ORDER:** This Emergency Closure Order is effective from December 5, 2011 and until this Order is terminated.

**PROHIBITED ACTS:** Operating any type vehicle into or upon or within any part of Forest Service System Road 920A, which is located in Unit 71 wholly within the Lyndon B. Johnson National Grassland in Wise County, Texas, and identified on the attached map.

Definition: For the purposes of this Prohibition, a Forest Service System Road has that definition found in 36 CFR 261.2.

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this Order:

- a. Persons with permission from a forest officer;
- b. Persons with a permit specifically authorizing the otherwise prohibited act or omission; and
- c. Any Federal, State, or Local Law Enforcement Officer or member of an organized rescue or fire fighting force in the performance of an official duty.

These prohibitions are in addition to the general prohibitions in 36 CFR Part 261, Subpart A.
