Passes are valid on both the Middle Fork of the Salmon and the Main Salmon rivers for Recreation Fees only.

Cost = \$40.00. If Pass Holder also has a Senior Pass (Golden Age) or Access Pass (Golden Access), cost is \$20.00.

The Annual Interagency Pass is not valid for the special recreation fees on the Salmon or the Middle Fork.
