Dear Mr. and Mrs. Berner:

This is formal notification that you are in noncompliance with the terms and conditions of the special use authorization issued to you on March 27, 2008, for the purpose of operating and maintaining a commercial pack station on the Inyo National Forest. Violation occurred you failed to submit required use reports by the 15th of September for the previous month's use. Use reports (tally sheets) are due to my office the 15th of each month as set forth in the May 8, 2008 Order for Injunctive Relief. This letter is to advise you of your current noncompliance and potential consequences if you fail to regain compliance. The following permit and annual operating plan provisions were violated during the 2009 operating season:

1. **2011 Annual Operating Plan, section III. A. Injunctive Relief, Item 3(6)**

2011 Annual Operating Plan section IV. A. 7.

Item 3(6): 3f. By the 15th of each month, each permittee shall submit to the Forest Service records of all services provided during the prior month.

Your permit administrator received, by facsimile, your use report for Sequoia Kings Pack Trains on September 18, 2011 and the report for Pine Creek Pack Station on September 19, 2011.

To remedy this noncompliance, tally sheets must be submitted on or before the 15th of the month for the remainder of the 2011 season. Subsequent violations of the requirement will result in an unacceptable performance rating and the reduction of your total annual service day allocation for each outfit, either effective immediately or applied to the 2012 season.

This notice of noncompliance regarding the violation of the court order serves as an opportunity for you to take corrective action, but does not constitute a decision that affects your authorized use or occupancy.
