PROHIBITIONS



FOREST SUPERVISOR ORDER NO. 08-13-01-12-02 OLD ALDRIDGE MILL AND TOWN HISTORICAL SITE (41JP82)

Pursuant to 36 C.F.R. 261.50(a) and (b), and 261.53 for the protection of public health, safety, resources, and historical areas, the following acts are prohibited on the Angelina National Forest located in Jasper County, Texas. The Old Aldridge site consists of approximately 600 acres, and boundaries of the area of prohibited acts are delineated as follows. *North Boundary*: Forest Development Road 326A; *East Boundary*: Forest Development Road 326; *South Boundary*: Neches River; and *West Boundary*: Boykin Creek. The areas affected by this Order are shown on the attached map. This Order is in effect from February 8, 2012 until February 8, 2016 or until rescinded.

1. **Camping is prohibited. 36 CFR 261.58(e)**
2. **Building, maintaining, attending or using a fire, campfire or stove fire is prohibited. 36 CFR 261.52(a)**
3. **Possessing or consuming a beverage, which State Law defines as an alcoholic beverage is prohibited. 36 CFR 261.58(bb)**
4. **Possession of paint or paint containers is prohibited. 36 CFR 261.53(c)**
5. **Being in the area after sunset or before sunrise is prohibited. 36 CFR 261.58(l)**
6. **Discharging a firearm, air rifle or gas gun is prohibited. 36 CFR 261.58(m)**
7. **Possessing, storing or transporting horses is prohibited. 36 CFR 261.58(s)**

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this Order:


- a. Persons with a permit specifically authorizing the otherwise prohibited act or omission.
- b. Any Federal, State, or Local Law Enforcement Officer or member of an organized rescue or fire fighting force in the performance of an official duty.

These prohibitions are in addition to the general prohibitions in 36 CFR Part 261, Subpart A.
