SPECIAL ORDER OF FOREST SUPERVISOR
UINTA-WASATCH-CACHE NATIONAL FORESTS
PLEASANT GROVE RANGER DISTRICT

PROHIBITING ALCOHOLIC BEVERAGES

PROHIBITIONS:

Pursuant to 36 CFR, Section 261.50 (a) and (b), **the following acts are prohibited** on the areas as described by this Order, all within the Pleasant Grove Ranger District, Uinta-Wasatch-Cache National Forests. This Order is in effect until further notice.

1. **Possessing a beverage** which is defined as an alcoholic beverage by Utah State Law, (See attached Utah State Law 32B-1-102(3)). [36 CFR 261.58(bb)]

EXEMPTIONS:

Pursuant to 36 CFR 261.50 (e) the following persons are exempt from this order:

1. Persons with special use authorization or other Forest Service authorization specifically exempting them from the effect of this Order.
2. Federal or State administrative personnel in performance of an official duty.

AREA DESCRIBED:

Upper Falls Park located in Provo Canyon in Township 5 South, Range 3 East, Section 34, all within the Salt Lake Base Meridian, as shown on attached map.


PURPOSE:

To prevent alcohol related accidents to visitors and employees, to prevent damage to public lands and facilities, and to prevent associated sanitation issues.

IMPLEMENTATION:

1. This Order will be in effect when signed and shall remain in effect until further notice.
2. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization and/or imprisonment for not more than 6 months. [Title 16 USC 551, Title 18 USC 3571(b)(6), Title 18 USC 3581(b)(7)].

Utah Code
Title 32B Alcoholic Beverage Control Act
Chapter 1 Alcoholic Beverage Control General Provisions
Section 102 Definitions.

32B-1-102. Definitions.

As used in this title:

- (1) "Airport lounge" means a business location:
 - (a) at which an alcoholic product is sold at retail for consumption on the premises; and
 - (b) that is located at an international airport with a United States Customs office on the premises of the international airport.
- (2) "Airport lounge license" means a license issued in accordance with Chapter 5, Retail License Act, and Chapter 6, Part 5, Airport Lounge License.
- (3) "Alcoholic beverage" means the following:
 - (a) beer; or
 - (b) liquor.
- (4) (a) "Alcoholic product" means a product that:
 - (i) contains at least .5% of alcohol by volume; and
 - (ii) is obtained by fermentation, infusion, decoction, brewing, distillation, or other process that uses liquid or combinations of liquids, whether drinkable or not, to create alcohol in an amount equal to or greater than .5% of alcohol by volume.
