

# Fell Camp



Located in the northern part of the Long Cane Ranger District, Fell Camp is primarily used by hunters and equestrians. In addition to 66 campsites situated on 15 acres, it offers other recreational opportunities such as biking, hiking and birding.

The surrounding forest environment sustains abundant wildlife, resulting in some of the most desirable upstate hunting areas. The camp also serves as the trailhead for the 26.7 mile Long Cane Horse Trail.

## Fees

- \$3 day-use fee per vehicle
- \$5 per night per campsite
- \$50 per month per campsite or \$150 per campsite for the entire season (September 14- January 4)
- **Self-serve fee station**

Campsites are first come, first served. Golden Age/ Golden Access discount only applies to day-use and overnight fees, not to monthly or season rates.

**Directions:** From Greenwood Mall (also known as Cross Creek Mall) take Hwy. 72 west towards Abbeville for 1.3 miles. Turn left onto Calhoun Road and travel 1.7 miles. Turn right onto Hwy. 10 and travel 6.2 miles. Turn right onto S 24-47 and travel 2.4 miles to entrance on left.

**Requirements:** A special permit is required for organized rides of 12 or more and overnight camping along the Long Cane Horse Trail. South Carolina hunting regulations apply. See [www.dnr.sc.gov](http://www.dnr.sc.gov) for more information.

**Safety:** Avoid trail use the first two weeks of rifle deer season. Wear blaze orange. Be mindful of traffic when traveling on or crossing roads. Shooting is not permitted within 300 yards of the camp.


