18 U.S.C. § 1001 makes it a crime for any person knowingly and willfully to make to any department or agency of the United States any false, fictitious, or fraudulent statements or representations as to any matter within its jurisdiction. The following is a description of the work to be done by a group of volunteers known as the Tombstone Shovel Brigade, a Non-profit organization that has offered their assistance to complete the work described below as agreed upon by the SVRD office and its supervisors.

The applicant information and the dates of the event appear on the form and the description of the proposed activity, the location and FS lands and facilities they (we) would like to use and the estimated number of participants and spectators is as follows:

Description and location of proposed work:

Gardner Spring

1. Use Boulders, rocks, sand and downed trees to fill in two gaps in an already existing naturally occurring earthen berm slightly upstream from the temporary collection pond and head wall. The berm is about 6 feet tall. One gap is about 10 feet long and the other is about 5 feet long.
2. Cut the steel head wall to existing ground level.
3. Use stones from debris field located in creek bed to build a rip-rap protection barrier around the head wall assembly and collection pipe.
4. Relocate valve assembly and conveyance pipe out of the direct water flow line (as much as possible). Secure the pipe to the creek bank using stakes, straps and cables.
5. Use boulders and flood debris currently distributed along the creek bed to build a rip-rap protective barrier along the relocated pipe path.
6. (If time and manpower permits) Use shovels and picks to install water bars on the existing Gardner Spring access road as discussed.

Miller Spring

1. To address the leaking valve in the steel 7" main pipeline two options are proposed:
 - a. Option one is to hand excavate around the leak and use rubber tape and a section of rubber liner clamped around the leak.
 - b. Option two is to hand excavate around the leak and expose a 4 foot section of the pipe to allow the removal of the valve by cutting the pipe approximately 2 feet on either side of the valve using a gas powered cut-off saw and replacing it with a new section of pipe using dresser couplings to eliminate the valve completely.

The tools needed to complete these tasks were discussed as follows: (or as approved by the FS regional forester)

1. Chain saw
2. Cordless Hammer Drill
3. Oxy / Acetylene cutting torch
4. Gas powered cut-off saw
5. Misc. hand tools – picks, shovels, hack saw, hand saw, wrenches and other hand tools necessary to secure the relocated pipe.

The Tombstone Shovel Brigade would like to use the parking area located at the Forest Service restroom facility located on Miller Canyon Road near the Coronado National Forest entrance as a staging area. They will be accompanied by City of Tombstone employees to coordinate the work. The anticipated number of participants/spectators will be around 200 people but may be more or less as the participation commitment is undetermined at this time. The work at Gardner and Miller Spring will be done in shifts and will include about 50 people at a time, rotating fresh workers into the work site as necessary. Workers will be shuttled to the Miller trail head via vans or trucks. The Sierra Vista Fire Chief has agreed to stage medical

personnel at the Miller Canyon Road staging area. The Cochise County Sheriff's office, Border Patrol and the Tombstone Marshall will be notified in regards to the event and are expected to be present to assist in security. Plans are being made to have four portable restrooms delivered to facilitate the large number of volunteers expected to attend. There will also be a drinking water table, an information table and volunteers on hand to assist with organizing parking logistics. The group will have garbage containers set up and will assist in the clean-up efforts during and after the event each day. Poster board signs will be placed at the entrance of the parking area to identify the group and will be set up and removed daily.
