***ROAD CLOSURE
(For Public Safety)***

PROHIBITIONS:

Pursuant to Title 36 CFR 261.50 (b) the following act is prohibited on the roads as described in this order, all within the administrative boundaries of the Idaho City Ranger District, Boise National Forest. This Order will be in effect when signed and shall remain in effect until further notice.

1. Using any type of motor vehicle on the road. **36 CFR 261.54(a).**

EXEMPTIONS:

Pursuant to 36 CFR 261.50 (e) the following persons are exempt from this order:

1. Persons with a special use authorization or other Forest Service authorization specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
3. Federal or State administrative personnel in the performance of an official duty.

NATIONAL FOREST SYSTEM ROADS DESCRIBED:

National Forest System (NFS) Roads 311K and 311K1 area described as beginning from the junction NFS Roads 311 (a.k.a. Warm Springs Ridge Road) & 311K to the end of NFS Road 311K and from the junction of NFS Roads 311K and 311K1 to the end of NFS Road 311K1.

The above described roads are within the administrative boundaries of the Idaho City Ranger District, Boise National Forest, Boise County and Elmore County, Idaho.

PURPOSE:

The roads described are temporarily closed to all motorized vehicles to provide for public health and safety due to work activity in the area. The roads will be posted as closed by the Forest Service. The closure will remain in effect until further notice.

IMPLEMENTATION:

1. This Order will be in effect when signed and shall remain in effect until further notice.
2. Maps (1) identifying the road closure are attached and made part of this Order.
3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000.00 for an individual or \$10,000.00 for an organization, and/or imprisonment for not more than six (6) months. [Title 16 USC 551, Title 18 USC 3571(b)(6), Title 18 USC 3581 (b)(7)].

5. This Order supersedes any previous Order(s) prohibiting the same or similar acts prohibited by this Order on the roads described in this Order.


