**CHRANDAL CREEK FIRE**  
**Emergency Trail Closure**

**PROHIBITIONS:** Pursuant to 36 CFR 261.50 (b), the following act is prohibited on the trails as described in this order, all within the North Fork Ranger District, Salmon-Challis National Forest until further notice:

1. Being on a trail described below that is posted as closed. **36 CFR 261.55(a)**

**EXEMPTIONS:** Pursuant to 36 CFR 261.50(e), the following persons are exempt from this order:

1. Persons with a permit specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.

**TRAIL CLOSURE DESCRIBED:**

**Forest Trail #106** known as the Divide Trail, will be closed beginning where it intersects the Spring Creek Road #038, Township 25 North, Range 18 East, Section 26, to its end at the intersection of the Saddle Mountain Road #081, Township 27 North, Range 21 East, Section 4.

**Forest Trail #141** known as the Henderson Ridge Trail, will be closed from where it starts at the Indian Creek Road #036, Township 25 North, Range 21 West, Section 30, to where it meets the Divide Trail #106 in Township 26 North, Range 21 West, Section 30.

**Forest Trail #110** known as the Butcherknife Ridge Trail will be closed from where it intersects Forest Road #088 in Township 25 North, Range 20 West, Section 3 to where it meets the #106 Divide Trail in Township 26 North, Range 21 West, Section 29.

**Forest Trail #105** will be closed from where it intersects the #088 road in Township 25 North, Range 20 West, Section 2 to where it intersects the #110 Trail in Township 25 North, Range 20 West, Section 3.

**Forest Trail #213** will be closed from where it intersects Trail #105 at Township 26 North, Range 21 West, Section 29, to where it intersects Trail #106 at Township 26 North, Range 21 West, Section 30.

**Forest Trail #142** will be closed from where it intersects the #088 Road in Township 25 North, Range 21 West, Section 18, to where it joins the #110 Trail in Township 26 North, Range 20 West, Section 34.

The above-described trails are located within the proclaimed and administrative boundaries of the North Fork Ranger District, Salmon-Challis National Forest, Lemhi County, Idaho.

**PURPOSE:**

These closures are necessary to provide protection to forest visitors from the current fire safety hazards associated with the **Chrandal Creek Fire**.

**IMPLEMENTATION:**

1. This Order will be in effect when signed and shall remain in effect until further notice.
2. A map identifying the closure area is attached and made part of this Order.
3. Any violation of this prohibition is punishable by a fine of not more than \$5,000.00 for a individual or \$10,000 for an organization, and/or imprisonment for not more than six (6) months. [Title 16 USC 551, Title 18 USC 3571 (b)(6), Title 18 USC 3581 (b)(7)].
4. This Order supersedes any previous orders prohibiting the same acts covered by this Order in the above-described area.
