**SPECIAL ORDER OF FOREST SUPERVISOR
UINTA-WASATCH-CACHE NATIONAL FOREST
PLEASANT GROVE RANGER DISTRICT**

TRAILHEAD CLOSURE

PROHIBITIONS:

Pursuant to Title 36 CFR 261.50 (a) and (b) **the following acts are prohibited** on Forest developed trailheads as described in this order, all lands affected are located on the Pleasant Grove Ranger District, Uinta-Wasatch-Cache National Forest. This order is in effect until further notice.

1. **Going into or being in Timpooneke Trailhead** as shown on the map
[36 CFR 261.55(a)] [36 CFR 261.53(e)]

EXEMPTIONS:

Pursuant to 36 CFR 261.50 (e) the following persons are exempt from this order:

1. Persons with special use authorization or other Forest Service authorization specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
3. Federal or State administrative personnel in performance of an official duty.

AREA DESCRIBED:

Forest Service Trailhead known as Timpooneke Trailhead (Forest Service Trailhead #053) located in Township 4 South, Range 3 East, Section 31, all within the Salt Lake Base Meridian as shown on the attached map.

PURPOSE:

Purpose of the Closure is to provide for health and public safety while construction crews and equipment are reconstructing the trailhead in order to accommodate more vehicles and improve traffic flow.

IMPLEMENTATION:

1. This Order will be in effect when signed and shall remain in effect until further notice.
2. Attached map shows the roads affected by this Order.
3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization and/or imprisonment for not more than 6 months. [Title 16 USC 551, Title 18 USC 3571(b)(6), Title 18 USC 3581(b)(7)].

5. This Order supersedes any previous Order(s) prohibiting the same, or similar acts prohibited by this Order in the areas (and/or roads or trails) covered by this Order.
