The Technical Evaluation Board has identified the following questions that need to be addressed. Please provide these answers in writing with your presentation out.

We look forward to further negotiations with your company.

- Please fill in the org chart with the known employees.
- How many of the primary types of equipment do you or your subcontractors have?
 - How many are needed?
- You state you would have 16 to 20 sides operating at any given time with sides averaging 9 acres. Why so small?
 - How will you provide supervision for each side?
- How many loads per day will you be hauling?
 - Where will you get the trucks?
- How will you maintain the roads to required level?
- What are the specific work/rest guidelines for your safety plan?
- How will you fund the in-woods operations until revenues are generated?
- What is the breakdown of resource costs (labor, equipment, etc) for the operations in the woods.

- You expect to treat 5,000 acres in year 1; 15,000 in year 2; and 30,000 starting in year 3. What is your proposal for outyears to reach the full 300,000 acres by the end of year 10.
- The economic impact study shows 207 FTEs created by commercial logging and 65 by transport by truck. How many of the transport jobs are needed to remove the material from the woods?
- Was any independent testing done on wood product to ensure it will meet the end product needs?
- How would you inspect and determine the rate of pay for a payment unit under a task order?
- In judging how critical the cogen plant will be, what percentage of biomass/mill waste would feed into the kiln, and be left over for cogen?
- Do you have a contingency plan if other markets are not available at this time?
