On 09/17/2012, at 10:00 AM, sealed bids will be opened in the Beckwourth Ranger District Office, 23 Mohawk Drive/HWY 70, Blairsden, CA for the McDermott MP Thin sale. This sale is located in all or portions of sections 1, 2, 3, 4, 8, 9, 10, 11, 12, T23N., R11E., sections 19, 30, T23N., R12E., and section 34, T24N., R11E., M.D.M.. Timber sale Contract 2400-6T will be used. The termination date for this sale is 03/31/2016.

There are 0.30 miles (0.48 kilometers) of specified road reconstruction. A specified road construction cost of \$2,889.62 has been allowed in the appraisal for this work.

The estimated quantities in this contract have been determined prior to felling. The total estimated quantity on this sale is 20,839 CCF.
