Forest Order # T-2012-0616-HC-04



Pursuant to 36 CFR, Sec. 261.50(a) and (b), the following acts are prohibited on the area described in this order within the Wallowa-Whitman National Forest, until further notice.

This closure is necessary to provide protection to forest visitors from the current fire safety hazards with the Cache Creek Fire in the Hells Canyon National Recreation Area. Safety hazards associated with fire suppression include; erratic wildland fire behavior, overhead support aircraft, fire fighter vehicles on roads, and use of heavy equipment for line construction and road maintenance.

- 1) It is prohibited to go into or be upon any area closed for the protection of public safety as described in Attachment A and Attachment B of this order.
36 CFR 261.53 (e)
- 2) It is prohibited to operate a motor vehicle on any forest service road or trail described in Attachment A and Attachment B of this order.
36 CFR 261.54 (a)
- 3) It is prohibited to operate a motor vehicle on Forest Service Rd. 46 from the junction of forest service road 4625 to junction with Thomason Meadow.
36 CFR 261.53 (a)

Pursuant to 36 CFR, Sec. 261.50(e), the following persons are exempt from this order:

- (1.) Persons with a permit specifically authorizing the prohibited act or omission.
- (2.) Any Federal, State or local law enforcement officer, or member of an organized rescue or firefighting force in the performance of an official duty.

These prohibitions are in addition to the general prohibitions in 36 CFR Part 261, Subpart A.

This order supersedes and terminates Forest Order T-2012-0616-HC-02

Supporting Documentation

Statement of Need:

This temporarily closure is needed to provide protection to forest visitors from entering current and potential wildland fire areas within the Cache Creek Fire in the Hells Canyon National Recreation Area. To reduce the exposure of forest visitors from safety hazards, certain areas, roads and trails will be closed. Safety hazards associated with fire suppression include; erratic wildland fire behavior, overhead support aircraft, fire fighter vehicles on roads, and use of heavy equipment for line construction and road maintenance. Forest Service Road 4680 was added to the closure due to private vehicles interfering firefighting operations.

Enforcement Procedures: Enforcement will be done by Law Enforcement Officers (LEO), Special Agents and Forest Protection Officers (FPO). If a person suspected of violating this order is observed, Officers will use discretion as appropriate when enforcing this order

Posting:

Posting will be provided by the Districts/ Forest and the forest order posted at the main road and trail entrances to the closure area

Attachment A

The external boundaries of the closure area are as follows;

From the western side of the Snake River at the Oregon and Washington state line, southeast along the wild and scenic river boundary of the Snake River (generally $\frac{1}{4}$ mile from the river's edge) to Trail # 1691. Following trail #1691 to Road #250. Following road #250 to trail #1705. Following trail #1705 to trail #1713. Following trail #1713 to trail #1731. Following trail #1731 to Cemetery Ridge Road. Following Cemetery Ridge Road to trail #1724. Following trail #1724 to the Powerline access road. Following the Powerline access road to the Dodson drainage and proceed due west for approx. 2.5 miles to Forest Road #46. Following forest road 46 northwest to forest road 4680. Following and including forest road 4680 north to the Wallowa-Whitman National Forest (WWNF) boundary in Horse Creek. From the intersection with forest road 4680 and the WWNF boundary follow the WWNF boundary north and east back to the western side of the Snake River at the Oregon and Washington state line.

Proposed Action:

Due to the current and potential fire activity it is proposed to prohibit use in the area, roads, and trails in the Cache Creek Fire area described in attachments A and B of this order. The closures are necessary to provide protection to forest visitors from the current fire safety hazards.

1. It is prohibited to go into or be upon any area closed for the protection of public safety as described in Attachments A and Attachment B of this order. **36 CFR 261.53 (e)**
2. It is prohibited to be on a road described in Attachments A and Attachment B of this order. **36 CFR 261.54 (e)**
3. It is prohibited to be on a trail described in Attachments A and Attachment B of this order. **36 CFR 261.56**

The following person's are exempt:

- (1.) Any Federal, State or local law enforcement officer, or member of an organized rescue or firefighting force in the performance of an official duty.
- (2.) Any Forest Service employee when engaged in the performance of their official duties
- (3.) Persons with a permit from an authorized forest service officer specifically authorizing the prohibited act or omission

This order is aimed at reducing and avoiding the public's exposure to hazards such as: erratic wildland fire behavior, overhead support aircraft, additional fire fighter vehicle traffic on roads, and use of heavy equipment for line construction and road maintenance.

1. Ensure signing is adequate in significant locations.
2. Periodically monitor to see if enforcement is being applied equally to all.
3. Periodic Monitoring of the resources to check for damage and to the soil moisture level
