

AREA CLOSURE for PUBLIC SAFETY

OKANOGAN-WENATCHEE NATIONAL FOREST

Pursuant to 36 CFR 261.50(a) and (b), the following acts are prohibited on the Okanogan-Wenatchee National Forest:

Back ground: Due to the large complex of fires occurring on the Wenatchee River Ranger District and fire fighter operations, closed areas are to maintain both public and fire fighter safety.

1. **To go into or be upon any area closed for protection of public health or safety.** For the purposes of this order, it is prohibited to enter or be within National Forest System lands, roads, or trails within the area of the Wenatchee River Ranger District closure area consisting of:

Closure Area 1:

Boundary beginning at the Chiwawa Road # 6200 and junction of the Rock Creek Trail Head, following north along Trail # 1509 to the Glacier Peaks Wilderness Boundary. East along the #1408 Trail to Marble Creek, following Marble Creek south to the Chiwawa #6200 Road and west following Chiwawa #6200 Road to the Rock Creek Trail Head.

Note: The Chiwawa Road #6200, Rock Creek Trail # 1509, and Garland Peak Trail # 1408 are open to public use.

[36 CFR 261.53(e)]

This closure is effective as of **Oct.--04th, 2012** and will remain in effect until terminated.

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this order:

1. Persons with a permit specifically authorizing the otherwise prohibited act or omission, including Washington State employees in performance of an official duty, and their authorized contractors.
2. Any Federal, State or local officer, or a member of any organized search and rescue, emergency services, or firefighting force in the performance of an official duty.
3. Any private land owner exercising an existing right to access their own private property which is otherwise within the closure area as described above.

This prohibition is in addition to the general prohibitions in 36 CFR Part 261, Subpart A.

Violations of these prohibitions are punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months, or both. (16 USC 551 And 18 USC 3559 and 3571)


