On 12/04/2012, at 10:00 AM, initial bids for Oral Auction will be opened in the Supervisor's Office, Umatilla National Forest, 72510 Coyote Road, Pendleton, OR 97801 for the South Park sale. This sale is located in T.7N.,R.43E.,SECTIONS 1,2; T.8N.,R.43E., SECTIONS 24-27,34-36; T8.N.,R.44E., SECTIONS 30,31; W.M., SURVEYED, ASOTIN COUNTY, WASHINGTON. Timber sale Contract 2400-6T will be used. The termination date for this sale is 03/31/2018. This is a small business set-aside sale.

This sale will be preferentially awarded to a qualified small business concern. In the absence of any bids from a self-certifying qualified small business concern, the sale will be readvertised without restriction on the size of bidders.

There are 13.88 miles (22.34 kilometers) of specified road reconstruction. A specified road construction cost of \$53,963.65 has been allowed in the appraisal for this work.

The estimated quantities in this contract have been determined prior to felling. The total estimated quantity on this sale is 27,764 CCF. The Forest Service encourages potential bidders to make their own inspection and estimate prior to bid submission.
