

Southwestern Region Centralized Temporary Hiring Outreach Notice—December 2012

The Southwestern Region is looking for a committed, hardworking, highly skilled workforce to work in many fields on 11 national forests located in Arizona and New Mexico. Working in the Southwestern Region is very rewarding and requires talented people working safely as part of a team in a variety of specialized positions; including Archeology, Range, Timber, Recreation, Engineering, Wildlife, Administration and Fire.

The Centralized Temporary Hiring process streamlines the hiring process for temporary fire, forestry and other positions and provides consistent hiring around the Region. This hiring process assists the national forests in the Southwestern Region to fill vacancies in a more efficient and timely manner.

Included is (1) the outreach for GS and WG 02 through 07 current temporary positions covered by the Open Continuous Rosters (OCRs); (2) the Outreach Notice Reply; and (3) instructions on how to apply.

The vacancy announcements for these positions are posted on USAJobs, the U.S. Government's official website for employment opportunities. There are Open Continuous vacancy announcements with no closing date. Apply by **January 11, 2013**. Applicants who have met the deadline and are found to be qualified and in the quality group will be referred for consideration to the selecting officials. **While the announcements are for current vacancies available in the Southwestern Region, please apply to any position and duty station you may be interested in as those positions may become vacant through the Centralized Temporary Hiring process.**

IMPORTANT: Complete the Outreach Notice Reply. Your response is important. Address your outreach response to the contact listed for each location. Additional information about the position is available from the direct supervisor.

The Process and Timeline

December 11, 2012—Outreach begins. See the Outreach Notice listing vacant temporary positions and locations from the GS and WG, 02 through 07 levels. **NOTE: Not all vacancy announcements are available at the opening of this Outreach period. The announcements should be available to applicants soon.**

January 11, 2013 — Application deadline. Apply through USAJobs. Applicants are encouraged to apply for multiple locations (**where they would accept a position if offered**), even if vacancies for certain locations are not listed as vacant. Vacancies may occur during the hiring process and could be filled during Selection Week.

January 28 – February 1, 2013—Application evaluation. Subject matter experts will generate reference evaluations for use by selecting officials.

February 4 - 8, 2013 — Selections, Representatives from each forest will make recommendations for hiring. Forest Service representatives will notify selected applicants by phone. Applicants not selected will be notified by e-mail.
