EMERGENCY PROHIBITIONS

FOREST SUPERVISOR ORDER NO. 08-13-08-13-03

Fire Restrictions

Pursuant to 36 CFR (Code of Federal Regulations) Part 261, Subpart B, the following acts are prohibited on the LBJ National Grasslands. The areas affected by this order are shown on the attached map. This Order is in effect from December 21, 2012 through March 31, 2013 or until rescinded.

1. **Building, maintaining, attending or using a fire, campfire or charcoal fire is prohibited throughout the above-named national grasslands. 36 CFR 261.52(a)**
2. **Using gas and propane grills, lanterns and stoves is prohibited throughout the above-named national grasslands. 36 CFR 261.52(a)**
3. **Violating any state or county law concerning burning or fires, which are for the purpose of preventing, or restricting the spread of fires is prohibited throughout the above-named grasslands. 36 CFR 261.52(k)**
4. **Smoking is prohibited throughout the above-named grasslands. 36 CFR 261.52(d)**

Exceptions to these Prohibitions:

- a. **Visitors may use gas and propane grills, lanterns, and stoves in developed recreation areas or designated hunter camps only.**
- b. **Smoking is allowed only within an enclosed vehicle or building, a developed recreation site, or while stopped in an area at least three feet in diameter that is barren or cleared of all flammable material.**

Pursuant to 36 CFR § 261.50(e), the following persons are exempt from this Order:

- a. Any Federal, State, or local law enforcement officer or member of an organized rescue or fire fighting force in the performance of an official duty.

These prohibitions are in addition to the general prohibitions in 36 CFR Part 261, Subpart A.


