## PROHIBITIONS

**FOREST SUPERVISOR ORDER NO. 08-13-08-13-04**

### **Windmill Lake**

Pursuant to 36 CFR (Code of Federal Regulations) Part 261, Subpart B, and for the protection of public health, safety and resources, the following acts are prohibited within the specified areas. This Order is effective from February 25, 2013 and ending February 26, 2018 or until rescinded.

**The following prohibitions apply to Windmill Lake and all areas within 20 feet of the water line on said Lake. Windmill Lake, which is located on Unit 2 of the Lyndon B. Johnson National Grasslands, is located in Wise County, Texas, as identified on the attached map.**

1. Windmill Lake is designated as a fly fishing lake. The only fishing permitted in Windmill Lake is fly fishing. All other forms of fishing are prohibited. 36 CFR 261.58(v)
2. The use of any motorized boat or motorized flotation device is prohibited. 36 CFR 261.58(n)
3. If caught, any fish of the bass species must be immediately released unharmed. The possession, retention or harming of any fish of the bass species is prohibited. 36 CFR 261.58(s) and (v).
4. Use of and possession of terminal tackle other than single barbless or crimped barb hook dressed with feathers, hairs tinsel, thread, or similar material, with or without a spinner, is prohibited. 36 CFR 261.58(v)

Pursuant to 36 CFR § 261.50(e), the following persons are exempt from this Order:

- a. Persons with a permit specifically authorizing the otherwise prohibited act or omission.
- b. Any Federal, State, or local law enforcement officer or member of an organized rescue or fire fighting force in the performance of an official duty.

These prohibitions are in addition to the general prohibitions in 36 CFR Part 261, Subpart A.




