

ORDER
COCONINO NATIONAL FOREST
RED ROCK RANGER DISTRICT
Campfire and Camping Prohibition

Pursuant to 16 U.S.C. 551, and 36 CFR § 261.50(a) and (b), the following acts are prohibited on all National Forest System lands within the Coconino National Forest, in Yavapai County in the state of Arizona. The area is depicted on the attached map, hereby incorporated into this Order as Exhibit A (the “restricted area”).

PROHIBITION:

1. Building, maintaining, attending, or using a campfire or stove fire; 36 CFR § 261.52(a)
2. Camping; 36 CFR § 261.58(e)

EXEMPTIONS:

Pursuant to 36 CFR § 261.50(e), the following persons are exempt from this closure order:

1. Persons with a Forest Service permit specifically authorizing the prohibited act or omission.
2. Any Federal, State or Local Officer or member of an organized firefighting force in the performance of an official duty.

AREA DESCRIPTION:

This order affects portions of Wet Beaver Creek, Bell Trail, Apache Maid Trail, White Mesa Trail, Weir Trail, Beaver Creek Campground and the Beaver Creek Ranger Station; specifically portions of Township 15 North, Range 7 East, Sections 19; Township 15 North, Range 6 East, Sections 21, 22, 23, 24, 25 and 28.

PURPOSE:

This Order is necessary to protect public’s health and safety from unsanitary conditions and exposure to wildland fire.

IMPLEMENTATION:

1. This Order will be in effect when signed and shall remain in effect until May 24, 2015 or until rescinded, which ever occurs first.
2. This Order rescinds, replaces and supersedes any previous Orders prohibiting the same acts covered by this Order in that area addressed in Exhibit A

Any violation of this prohibition is punishable as a Class B misdemeanor by a fine of not more than \$5,000 for individuals and \$10,000 for organizations or by imprisonment for not more than six (6) months, or both. [Title 16 USC 551, Title 18 USC 3559, 3571 and 3581].




