Lakes with special state regulations on the Grand Mesa National Forest:

- ◆ **Bull Basin Reservoir #1:** Artificial flies and lures only. Bag, possession and min. size limit for trout is two fish, 16 inches long.
- ◆ **Bull Creek Reservoirs #1 & #2 and Connecting Channels:** Artificial flies and lures only. Bag, possession & min. size limit for trout is two fish, 16 inches long.
- ◆ **Silver Lake:** Artificial flies & lures only. Bag, possession and min. size for trout is two fish, 16 inches long.
- ◆ **Youngs Creek Reservoir #1, 2, & 3:** Artificial flies & lures only. Cutthroat must be returned to the water immediately.
- ◆ **Kitson Reservoir** Bag, possession and minimum size for grayling is two fish, 16 inches long.
- ◆ **Griffith Reservoir:** Artificial flies & lures only. Bag, possession & minimum size limit for trout is two fish, 16 inches long.

Welcome to the Grand Mesa National Forest. Some of the finest fishing in the Western slope.

The Grand Mesa is commonly referred to as one of the "Worlds Largest Flattop Mountain." The Grand Mesa averages 10,000 feet in elevation and towers 6,000 feet above the surrounding Colorado and Gunnison river valleys. The Grand Mesa is well known for its numerous natural lakes. In all, some 300 lakes and reservoirs lie on the benches and top of the Grand Mesa. Of these, roughly a third provide the aquatic habitat needed to sustain trout populations. Primary boating use is by small watercraft with less than 10 hp motors.

Regulation: Forest order #01-03

The following restrictions are currently in place on the Grand Mesa National Forest:

1. No boats or other personal flotation watercraft are allowed on Carson Lake
2. Possessing or operating a motorboat or motorized raft on the following lakes & reservoirs:
 - **Beaver Reservoir**
 - **Blue Lake (Kannah Creek Drainage)**
 - **Bonita Reservoir**
 - **Butts Lake**
 - **Cobbett Lake**
 - **Colby Horse Park**
 - **Clear Lake**
