This document serves as Amendment #1 of your 2013 Annual Operating Instructions (AOI) for the Apache Maid Allotment. This amendment only affects section II Grazing Schedule, of the 2013 Annual Operating Instructions (AOI), to determine the dates and numbers for the remaining grazing year up to the shipping date. The rest of the AOI would not change.

I. AUTHORIZED LIVESTOCK NUMBERS/PERIOD OF USE/APPROVED NON-USE

II. GRAZING SCHEDULE

The Annual number of livestock and dates are considered approximate. The actual dates and numbers may change due to many variables. Annual stocking level (annual authorized livestock numbers and dates) is determined based on current and expected forage production; livestock numbers can/should be adjusted if conditions change (either up or down; but not in excess of the permitted numbers).

It was agreed that to provide a more accurate number of livestock and use period dates that two AOI meetings would be scheduled. The grazing schedule addressed in this AOI is from 6/5/13 through 10/14/13, another AOI meeting would be scheduled in late September to determine the dates and numbers for the remaining grazing year.

The following is the planned grazing sequence for the 2013 grazing season:
