ROAD CLOSURE

PROHIBITIONS:

Pursuant to Title 36 CFR 261.50(a) and (b), **the following acts are prohibited** on the National Forest system road described in this Order, all lands affected are within the Heber-Kamas Ranger District, Uinta-Wasatch-Cache National Forest. This order is in effect until further notice.

1. **Being on upon the road as** described below with any type of motorized vehicle. [36 CFR 261.54 (a)]

EXEMPTIONS:

Pursuant to 36 CFR 261.50 (e) the following persons are exempt from this order:

1. Persons with special use authorization or other Forest Service authorization specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
3. Federal or State administrative personnel in performance of an official duty.

AREA DESCRIBED:

The Spring Canyon-Trial Lake Road (Forest Service Road #80041) starting just passed the Trial Lake fisherman's parking area to the intersection with the Crystal Lake Road (Forest Service Road #80488) Township 2 South, Range 9 East, Sections 5 and 6 all within the Salt Lake Base Meridian. See attached map.

PURPOSE:

Purpose of this closure is to allow heavy equipment and construction crews to repair the Spring Canyon -Trial Lake Road (Forest Service Road #80041).

IMPLEMENTATION:

1. This Order will be in effect when signed and shall remain in effect until further notice.
2. Attached map shows the area affected by this Order.
3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization and/or imprisonment for not more than 6 months. [Title 16 USC 551, Title 18 USC 3571(b)(6), Title 18 USC 3581(b)(7)].
