Dear Prospective Bidder:

On 08/08/2013, at 02:00 PM, sealed bids will be opened in the District Ranger's Office, 131 Smokey Lane, Marienville, PA 16239 for the West End Renewal sale. This sale is located in Warrants 2560, 2571, 2575 and 2577, Hamilton Township, McKean County; Warrants 2568, 2571, 3092, 3120, 3121 and 3132, Wetmore Township, McKean County; Warrants 3777, 3783, 3784 and 3785, Highland Township, Elk County; Pennsylvania. Timber sale Contract 2400-6T will be used. The termination date for this sale is 09/30/2016.

There are 1.50 miles (2.41 kilometers) of specified road reconstruction, and 0.30 miles (0.48 kilometers) of specified road construction. A specified road construction cost of \$42,169.00 has been allowed in the appraisal for this work.

The estimated quantities in this contract have been determined prior to felling. The total estimated quantity on this sale is 3,269 CCF. 
