FIRE CLOSURE SPECIAL ORDER**

PROHIBITIONS:

Pursuant to Title 36 CFR 261.50 (a) and (b) the following act is prohibited on the area, roads, and trails as described in this order, all within the Ely Ranger District, Humboldt-Toiyabe National Forest until further notice.

1. To go into or be upon the area. 36 CFR 261.53(e)
2. Being on the road. 36 CFR 261.54(e)
3. Being on the trail. 36 CFR 261.55(a)
4. Parking or leaving a vehicle in violation of posted instructions.
36 CFR 261.58(g)

EXEMPTIONS:

Pursuant to 36 CFR 261.50 (e) the following persons are exempt from this order:

1. Persons with a special use authorization or other Forest Service authorization specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
3. Federal or State administrative personnel in the performance of an official duty.

AREA, ROADS, AND TRAILS DESCRIBED:

See attached map – All trails and roads within the following area:

The White River Campground and Forest Road # 59405 from Forest Boundary to the junction of Forest Road # 59650. Forest Road # 59407 from the junction of Forest Road # 59405 south to Highway 6. Forest Road #59644 in its entirety. Forest Service Road # 59610 from junction of Forest Road # 59407 to Forest Service Boundary.


PURPOSE:

These trails and roads will be closed to provide for firefighter and public safety during ongoing firefighting operations on the Fire.

IMPLEMENTATION:

1. This Order will be in effect when signed and shall remain in effect until further notice.
2. A map identifying the closures is attached and made part of this Order.
3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000.00 for an individual, or \$10,000.00 for an organization, and/or imprisonment for not more than six (6) months. [Title 16 USC 551, Title 18 USC 3571(b)(6), Title 18 USC 3581 (b)(7)].

5. This Order supersedes any previous Order(s) prohibiting the same, or similar acts prohibited by this Order in the areas (and/or roads, trails) covered by this Order.


