



## MALHEUR NATIONAL FOREST

Forest Order # T2012-0604-MAL-06

### FIRE RESTRICTIONS

Pursuant to 36 CFR, Sec. 261.50(a) and (b), the following acts are prohibited on all areas of the Emigrant Creek Ranger District of the Malheur National Forest, until further notice:

1. It is prohibited to build, maintain, attend or use a fire, campfire, or stove fire. For the purpose of this order, this restriction applies to building, maintaining, attending or using a fire, campfire, or stove fire outside of the developed recreation sites listed in Exhibit A of this order, except for liquefied and bottled gas stoves and heaters, and except for stove fires within permanent residential structures. **36 CFR 261.52(a)**
  
2. It is prohibited to operate an internal combustion engine. For the purpose of this order, this restriction applies to all internal combustion engines other than motor vehicles, except for electrical generators operated under the following conditions:
  - (a.) In the center of an area at least 10 feet in diameter that is barren or cleared of all flammable material, or;
  - (b.) When fully contained within a pickup truck bed that is devoid of all flammable material, or;
  - (c.) When factory installed in a recreational vehicle and the generator exhaust discharge is located in the center of an area at least 10 feet in diameter that is barren or cleared of all flammable material.**36 CFR 261.52 (h)**
  
3. Smoking is prohibited, except within an enclosed vehicle or building, a developed recreation site, or while stopped in an area at least three feet in diameter that is barren or cleared of all flammable material (**36 CFR 261.52 d**).
  
4. It is prohibited to possess or use a vehicle off National Forest System roads. For the purpose of this order, this restriction applies to use or possession of motorized vehicles off National Forest System roads and off National Forest System trails, except for the purposes of going to and from campsites when such campsites are located within 300 feet of an open National Forest System road. **36 CFR 261.56.**

Pursuant to 36 CFR, Sec. 261.50(e), the following persons are exempt from this order:

- (1.) Persons with a permit specifically authorizing the prohibited act or omission.
  
- (2.) Any Federal, State or local law enforcement officer, or member of an organized rescue or firefighting force in the performance of an official duty.
