ORDER
USDA - FOREST SERVICE - COCONINO NATIONAL FOREST
RED ROCK RANGER DISTRICT
Glass Food and Beverage Containers Prohibited

Pursuant to Title 16 36 CFR 261.50 (a) and/or (b), the following acts are prohibited in areas as described in this Order on National Forest System lands administered by the Coconino National Forests, in Coconino County in Arizona, and as depicted on the attached map, hereby incorporated into this Order as Exhibit A.

PROHIBITIONS:

1. Possession or use of glass containers within 300 feet of the streamside, 36 CFR 261.58 (cc).

EXEMPTIONS:

Pursuant to 36 CFR 261.50 (e) the following persons are exempt from this order:

1. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty; and
2. Person(s) with a Forest Service permit specifically authorizing the otherwise prohibited act or omission.
3. Possession of glass containers within a motor vehicle, or within a Forest Service recreation developed site boundary.

AREA DESCRIBED:

This order affects the Coconino National Forest, Red Rock Ranger District at locations on National Forest lands adjacent to Oak Creek. The affected area begins at the State Highway 89A Bridge which marks the confluence of Oak Creek and Pumphouse Wash. The closure area continues downstream on National Forest lands for approximately 15 miles to end at the downstream (western) boundary of the USFS Crescent Moon Ranch Picnic Area as shown on the map in Exhibit A. The prohibition includes National Forest land within 300 feet of the streamside.


PURPOSE:

This order is needed to ensure public health and safety.

IMPLEMENTATION:

1. This Order will be in effect when signed and shall remain in effect until December 15, 2017 or until rescinded, whichever event occurs first.
2. This Order rescinds, replaces and supersedes any previous Orders prohibiting the same acts covered by this Order in areas addressed by Exhibit A.
