The Mountain Fire Closure Area boundary begins at the intersection of the northern boundary of the San Bernardino National Forest and the Southern Boundary of the Mt. San Jacinto State Park Wilderness and the Pacific Crest Trail (PCT), Section 33, Township 4 South, Range 3 East, San Bernardino Meridian and Baseline, then continues south paralleling the PCT 100 feet to the east to its intersection with Forest Trail No. 3E02 and Forest Trail 3E41, then continues southward paralleling Forest Trail No. 3E41 200 feet to the east to its intersection with the PCT, then continues southwest paralleling the PCT 200 feet to the south to its intersection with Forest Trail No. 3E08.1, then continues southward paralleling Forest Trail No. 3E08.1 100 feet to the east to its intersection with Forest Road No. 5S21, then continues southeast along Forest Road No. 5S21 to its intersection with the northern section line of Section 29, Township 5 South, Range 3 East, then continues west along the northern section line of Sections 29 and 30 to its intersection with the western section line of Section 30, then continues south along the western section line of Section 30 to its intersection with the entrance of Keenwild Fire Station on State Highway 243, then continues northeast and southerly along the Keenwild Fire Station administrative boundary to its intersection with the western section line of Section 30, then continues south along the western section line of Section 30 to its intersection with State Highway 74, then continues southeast along the northern edge of State Highway 74 to its intersection with a point 150 feet south of the northern section line of Section 31, then continues eastward paralleling the northern section line of Sections 31 and 31 150 feet south to its intersection with a point 100 feet east of Forest Road No. 5S05, then continues south paralleling Forest Road No. 5S05 100 feet to the east to its intersection with the northern section line of Section 5, Township 6 South, Range 3 East, then continues east along the northern section line of Sections 5 and 4 to its intersection with the midpoint of Section 4, then continues south to its intersection with the northern edge of the forest boundary, then continues east and south along the forest boundary to its intersection with Apple Canyon Road, then continues northeast along the western side of Apple Canyon Road to its intersection with the northern section line of Section 3, then continues east along the northern section line of Section 3 to its intersection with the western boundary of the San Jacinto Wilderness, then continues southeast along the San Jacinto Wilderness boundary to the northern section line of Section 14, then continues eastward along the northern section line of Section 14 to its intersection with Forest Road No. 6S05, then continues northeast along the western edge of Forest Road No. 6S05 to its intersection with the northern edge of the southern quarter of Section 12, then continues eastward along the northern edge of the southern quarter of Section 12, Township 6 South, Range 3 East, and sections 7 and 8, Township 6 South, Range 4 East, to its intersection with Forest Trail No. 4E17, then continues northeast paralleling Forest Trail No. 4E17 100 feet to the west to its intersection with the PCT, then continues east along the southern edge of the northern quarter of Section 9 to its intersection with the western section line of Section 10, then continues north along the western section line of Sections 10 and 3 to its intersection with the forest boundary, then continues north and west along the forest boundary back to the starting point, as shown on Exhibit A.
