

This is a combined synopsis/solicitation for commercial items prepared in accordance with the format in Subpart 12.6, as supplemented with additional information included in this notice. This announcement constitutes the only solicitation. Quotations are being requested and a written solicitation will not be issued. Solicitation AG-52B1-S-14-0002 is being issued as a Request for Quotation (RFQ), for providing custodial services for the Tell City Ranger District, Hoosier National Forest, Tell City, IN. Contractor shall provide custodial services three times a week between 4:30p.m. and midnight. Approximate square footage of all building is 5,300sf. The government will provide paper products and hand soap. Contractor will provide all equipment and cleaning products (all cleaning products must be bio or green products). This acquisition is set-aside for *Woman Owned small businesses*. The North American Industry Classification System (NAICS) code is 561720 and the size standard is \$16.5mil.
