


# Peters Mill Run & Taskers Gap OHV Trails

The Lee Ranger District offers two trail systems for all-terrain vehicles and other off-highway vehicle enthusiasts: Peters Mill Run Area and Taskers Gap ATV/OHV Complex. Both systems can be accessed off State Route 675 southeast of Edinburg, Va.

## Operating Conditions

Virginia state law prohibits riding double and requires operators of motorcycles and ATVs to wear safety helmets. Youth between the ages of 12 and 16 years are permitted to operate ATVs of no less than 70cc nor more than 90 cc. Children under the age of 12 are not permitted to operate ATVs.

Operating any vehicle under the following conditions is prohibited in the George Washington and Jefferson National Forests:

- Without a valid operator's license or learner's permit as required by the law of the state in which the vehicle is being operated
- Without a valid vehicle license as required by state law where the vehicle is maintained
- On any trail not specifically designated for motorized travel
- Traveling cross-country by not staying on the roads and trails
- Using any vehicle without a muffler and spark arrestor or one that exceeds a noise limit of 99 db at 20 inches at test rpm
- Possessing any beverage which is defined as an alcoholic beverage by state law or while under the influence of alcohol or drugs
- In a careless or reckless manner or in a manner that may endanger any person or property
