Find rewarding and challenging work with the USDA Forest Service at the Columbia River Gorge National Scenic Area. We are recruiting positions for our Recreation Team including Recreation Technician and Park Ranger positions for several Recreation Programs including the Field Ranger Program (Hood River, OR), Visitor Information Center at Multnomah Falls (Bridal Veil, OR) and Recreation Operations (Hood River, OR).

#### THE POSITIONS

These positions are temporary seasonal in nature and are part of our Recreation program. Our positions begin in May/June, and continue into September/October, depending on exact position. Applications for all positions can be found at <https://www.usajobs.gov/>.

Applicants with a strong work ethic, a desire to work outdoors and possession of excellent customer service skills are encouraged to apply.

Field Ranger positions are based out of Hood River, OR or the Multnomah Falls Recreation site in Bridal Veil, OR. Job tasks include providing customer service and visitor education, routine trail and site maintenance and sharing the mission of the USDA Forest Service with visitors to the area.

Recreation Operation positions are based out of Hood River, OR. In this position the employee visits recreation sites and trailheads to provide maintenance including restroom cleaning, emptying garbage cans, picking up litter and organizing information boards. Fee collections, delivering forest passes to local vendors, supplying site volunteer hosts with materials and assistance with trail maintenance are also part of the various duties.

#### THE COLUMBIA RIVER GORGE NSA

The Columbia River Gorge National Scenic Area stretches along the Columbia River between the Deschutes River and the Sandy River in Oregon, and Maryhill and Washougal on the Washington side. The cities of Hood River, The Dalles, Stevenson, White Salmon, and several smaller communities all fall within the Scenic Area. The Portland Metro area borders the Scenic Area 30 miles West of Cascade Locks on Interstate 84.
