Digest:

This interim directive (ID) provides the 2014 schedules for cost recovery fees, the 2014 Adjusted Gross Revenue Brackets for the Ski Area Permit fees, and 2014 update for the IPD-GDP. Fee schedules issued in id_2709.11-2012-3, remain in effect until December 31, 2013.

31.31 - Provides the CY 2014 updates for Cost Recovery rates with exhibit 01, Processing Fee Schedule for Special Use Applications and exhibit 02, Monitoring Fee Schedule for Special Use Authorizations. The CY 2014 rate update to the Forest Service Handbook, required by 36 CFR 251.58(i), reflects the 1.017 percent increase from the CY 2013 rates, based on the IPD-GDP yearly update found in section 36.41.

Digest--Continued:

36.41 - Provides the CY 2014 update to exhibit 01, Cumulative Implicit Price Deflator-Gross Domestic Product, and exhibit 02, Linear Right-of-Way Fee Schedule. Exhibit 01 updates the Implicit Price Deflator-Gross National Product for 2013 (for use in calculating CY 2014 land use and cost recovery fees).

Exhibit 02 directs users to the website location that contains the linear Rights-of-Way fee schedule. This fee schedule, developed by the Bureau of Land Management (BLM) is used by the Forest Service to determine linear Rights-of-Way fees.

38.12 - Provides the 2014 update to exhibit 01, Adjusted Gross Revenue (AGR) Brackets and Associated Percentage Rates for Use in Determining Ski Area Permit Fee (SAPF) and updates the Consumer Price Index (CPI) for 2013 (for the purpose of calculating the Holders' FY 2014 land use fees). This exhibit supersedes 38.12, exhibit 01 found in id_2709.11-2012-3 and corrects the upper value in bracket 2 and the lower value in bracket 3.

A direct link to the CPI-U table used in the calculations was added to the footnote of exhibit 01 to aid locating the table.

Since 1987 the Forest Service and the Bureau of Land Management (BLM) jointly developed and maintained identical Linear Rights-of-Way fee schedules. With the implementation of the updated Fair Market Value schedule required by Section 367 of the Energy Policy Act of 2005 the BLM is responsible for the development and updates to the schedule.

*The Washington Office, Director of Recreation, Heritage, and Wilderness Resources, updates the revenue brackets annually, based on the Consumer Price Index (CPI-U), Table A which is published monthly at <http://www.bls.gov>. The CPI is revised and issued annually in section 97. Currently the table is located at <ftp://ftp.bls.gov/pub/special.requests/cpi/cpi.ai.txt>.

The bracket update is accomplished by using the change in the CPI-U for "All Urban Consumers" index for the month of July and is based on the percentage increase or decrease for the preceding calendar year. This index base period is 1982-84=100. For example, the 2011 adjustment uses the change between July 2009 and July 2010, "Not Seasonally Adjusted" values.
