The Humboldt-Toiyabe National Forest is currently advertising for temporary (NTE 1039hrs) Fire Engine, Hotshot, Helitack and Dispatch positions for the 2014 fire season. Openings may be available at the GS-03, GS-04, and GS-05 grade levels, with temporary duty locations located in **Las Vegas, Minden, Carson City, Reno, Austin, Ely and Elko Nevada; and in Bridgeport, Topaz and Markleeville California** depending on staffing needs and budgets. These are temporary wildland fire positions, with a three to six month tour of duty. Our earliest anticipated start date is late April or early May 2014, and we expect to operate until late September or early October.

All applications must be processed through www.usajobs.gov , an online application service used by the USDA Forest Service.

WORK CAPACITY TEST (WCT) for Wildland Firefighters: These positions participate in wildland firefighting activities. Based on the type of work performed, TAKING and PASSING the WCT at the ARDUOUS level is a "condition of employment." The Arduous fitness (Pack) test consists of a three (3) mile hike, within forty-five (45) minutes, while carrying a forty-five (45) pound pack. You are strongly encouraged to consult with your physician and begin training immediately if you are applying for these positions. This announcement constitutes the required 30 days advanced notice for testing requirements.

About the Forest

At over 6.3 million acres, the Humboldt-Toiyabe National Forest is the largest National Forest in the contiguous United States. The Forest spans the state of Nevada, and includes one million acres of land in eastern California, along the eastern Sierra Front. The Forest consists of four distinct geographic areas: the Sierra Nevada, Central Nevada, Northeastern Nevada, and the Spring Mountains (Las Vegas).

How to Apply

Through the announcement (when available) you may be instructed to electronically attach additional information (e.g.; resume, DD-214, SF-50, training documentation/certificates, college transcripts, etc.)

The applicant must select the desired “Duty Location City” in order to be considered.

Announcements for these positions are on the USAJOBS website. These web-based applications provide individuals interested in employment opportunities with the Forest Service to apply for jobs. You must log into USAJOBS to create an account and an applicant profile. www.usajobs.gov.
