

Sewee Visitor and Environmental Center



The Sewee Visitor Center showcases the unique heritage and natural history of South Carolina's lowcountry. Jointly operated by the U.S. Forest Service and U.S. Fish and Wildlife Service, the 9,000-square-foot facility features hands-on interpretive displays on the unique and valuable ecosystems of the forest and refuge.

In addition, Sewee Visitor Center features tourist information on recreational opportunities available on the Francis Marion National Forest and Cape Romain National wildlife refuge.

The center features a live red wolf education area to increase knowledge and understanding of this endangered species.




