TEMPORARY ROAD CLOSURES

PROHIBITIONS:

Pursuant to 16 USC 551 and 36 CFR 261.50 (b) the following acts are prohibited on the roads as described in this Order, and as depicted on the attached map hereby incorporated into this Order as Exhibit A (the "restricted roads"), within the Sandia Ranger District, Cibola National Forest and National Grasslands, Bernalillo County, New Mexico.

1. Possessing or using a motorized vehicle (including ATV's and OHV's) on the restricted roads described below.

EXEMPTIONS:

Pursuant to 36 CFR 261.50 (e) the following persons are exempt from this order:

1. Persons with a Forest Service permit specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.

RESTRICTED ROADS DESCRIBED:

The restricted roads are described as follows:

1. National Forest System Road (NFSR) 462 from the Forest boundary on the east boundary of Sec 19 of T.10N., R.6E. to the Chamisoso Trailhead (T.10N., R.5E. Sec 26).
2. NFSR 252 from the Forest boundary (T.10N., R.6E. Sec 31) to the junction with NFSR 542.
3. NFSR 12 (T.10N., R.6E. Sec 30-32).
4. NFSR 13 (T.10N., R.6E. Sec 30-31 & T.10N., R.5E. Sec 36).
5. NFSR 542 (T.10N., R.5E. Sec 36 & T.9N., R.5E. Sec 1).
6. NFSR 445 (T.12N., R.4E. Sec 1-3 & 10-12).


PURPOSE:

The purpose of this Order is to protect resources and to provide for public health and safety on road surfaces and sub-surfaces damaged by the effect of winter weather.


IMPLEMENTATION:

1. This Order will be in effect when signed and shall remain in effect until rescinded or until May 31, 2014, whichever event occurs first.
2. Violation of this prohibition is punishable by a fine of not more than \$5,000.00 for individuals or \$10,000.00 for organizations, or imprisonment for not more than six (6) months, or both. [Title 16 USC 551, Title 18 USC 3559, 3571 and 3581].
3. This Order supersedes, rescinds, and replaces any previous order prohibiting the same acts covered by this Order


